For new members of Inter-County Energy, this concept may be difficult to grasp. Why should a power company care about me? Isn't it just some corporation that says things like that to sound good to its shareholders?

Inter-County Energy advocates for our members because we belong to our members. As a cooperative, there are no out-of-town shareholders or parent companies profiting off our members. Inter-County Energy is a not-for-profit utility that, from the very beginning in 1937 to this day, has been led by and owned by the people we serve.

It means being your consumer-advocate and standing up for your rights, interests and needs. Here are some key ways we advocate for you:

AFFORDABLE RATES

Inter-County Energy works, along with its power supplier, to keep electric rates as low as possible. We not only advocate for fair, just and reasonable rate structures, but our cooperative team also is accountable to members to manage our operations efficiently. This ensures that we can offer some of the most competitive electricity rates in the country.

RELIABILITY

We understand the essential role electricity plays in your daily life. Our cooperative invests in maintaining and upgrading our infrastructure to ensure a reliable power supply. We advocate for robust and resilient systems to minimize outages, and when they do occur, we strive to restore power quickly.

MEMBER EDUCATION

An informed member is an empowered member. We advocate for your right to understand your energy consumption and how to use electricity efficiently. Through workshops,

COMMUNITY ENGAGEMENT



ENHANCING EFFICIENCY AND MEMBER VALUE THROUGH NEW TECHNOLOGY

In the coming months, Inter-County Energy will upgrade its metering system with a new advanced meter, providing our members with improved access to their daily usage patterns and usage data in 60-minute increments, along with other usage-management options.

Inter-County Energy has partnered with Luthan Electric Meter to conduct this meter exchange project on behalf of the cooperative, a project approved by the Kentucky Public Service

Commission. Here are a few key points to remember during this process:

- 1. Members do not need to be at home during the installation of the new meter, but Luthan will require access to the cooperative meter. The meter exchange process will only take a few minutes, with a brief power interruption once the exchange is complete.
- 2. Luthan's contracting vehicles will be clearly marked, and their employees will carry appropriate identification, including truck signs.
- 3. If you have any questions during this process, please do not hesitate to contact Inter-County Energy's offices at (859) 236-4561.
- 4. To pay your bill online and access these new options, download our new SmartHub mobile app from the Google Play or Apple App stores. For more information on signing up, call our offices in Danville or Lebanon.
