# **Co-op employees help out at Ronald McDonald Houses**

mployees from Inter-County Energy Cooperative, along with others from Kentucky's Touchstone Energy Cooperatives, recently helped do some spring sprucing up at the Ronald McDonald House of the Bluegrass in Lexington and Ronald McDonald House Kentuckiana in Louisville.

As one of co-ops' core values, commitment to community, employees provided a helping hand at the facilities, which serve families of children receiving treatment at nearby hospitals.

Volunteers helped with the Lexington facility's landscaping, assembled two new guest closets and organized the pantry. In Louisville, they pulled weeds, trimmed bushes, raked leaves and laid mulch for the house, making it a little nicer for the families staying there during a difficult time.

Kentucky's Touchstone Energy Cooperatives have supported both of the Ronald McDonald Houses in Kentucky, located in Louisville and Lexington, for six years through sponsorships and volunteer efforts. Since 2017, co-ops have raised more than \$42,000 worth of goods, collectively, for the houses' Wish List Drives each July.

# To protect against electrical hazards, know the **Pool rules**

othing beats a plunge in a backyard pool on a hot summer day. To ensure you're splish-splashing safely, take the necessary steps to protect against electrical hazards.

Know and follow these pool rules:

- All outdoor receptacles should be GFCI (ground fault circuit interrupter)-protected, covered and dry. Test GFCIs monthly to ensure they are functioning properly.
- All electrical equipment used for the pool, even the cleaning equipment, must be grounded.
- Keep electrical devices and cords at least 10 feet away from water sources.
- Don't handle any device that is connected to a live electrical current while wet or touching wet surfaces. Safer: Use battery-operated appliances.
- Carry long-handled cleaning tools horizontally and stay at least 10 feet away from power lines.
- Never string electric lights above or near swimming pools.



- Label power switches so they can be turned off quickly in an emergency.
- Watch for flickering lights, which may indicate an electrical failure or loose connection. Don't go into the water until a licensed electrician checks the problem.
- Never go in the water during a thunderstorm.

It can be easy to overlook, but electrical safety is extremely important around water. Remember and abide by the pool rules.

## You help make Summer Games special

This is the 15th year Amanda Bass has participated in Special Olympics competition. She'll compete as a member of the Grant County Titans soccer team. Participating in Special Olympics is a family affair at the Bass home, which is served by Owen Electric Cooperative in Williamstown. Mom Beverly will be among the nearly 500 volunteers cheering on athletes at the games. About 100of Kentucky's Touchstone Energy employees and their families will also be there.

Track and field competitor Matthew Helton, 17, of Richmond hopes to be a top finisher in the 200-meter and 400-meter dash. But winning a medal isn't the real prize, says his dad.

"I've seen him have more confidence in himself," says Cesar Meija, a member of Blue Grass Energy.

Very few of the athletes participating in the Summer Games care about whether there's an award waiting at the finish line. This event is more about smiles and cheers. That's why I'm pleased that Inter-County Energy chooses to improve the quality of life in our communities and state through a Special Olympics sponsorship.
