RE: Notice – Case No. 2026-00188 – *In the Matter of: Electronic Tariff Filing of East Kentucky Power Cooperative, Inc. and Its Member Distribution Cooperatives for Updates to the Renewable Energy Program*

This letter is to provide notice regarding the recent filing of Inter-County Energy Cooperative Corporation (“Inter-County Energy”) with the Kentucky Public Service Commission (“Commission”) for a change to its Renewable Energy Program tariff to coincide with the same changes made by East Kentucky Power Company, Inc. (“EKPC”) to its Renewable Energy Program tariff. The tariff filing was made on June 30, 2026 with a proposed effective date of August 1, 2026. However, the Commission has initiated the above-styled case and has suspended the tariff and the effective date up to and including December 29, 2026. The Commission’s Order along with the tariff filing that was made can be found on the Commission’s website at the following link: https://psc.ky.gov/pscscf/2026%20Cases/2026-00188/20260720_PSC_ORDER.pdf. The tariff can take effect sooner than December 29, 2026 if the Commission issues an Order approving the changes prior to that date. Although you are not currently taking service under this tariff, the special contract that you have entered into with EKPC and Inter-County Energy provides for service under this tariff at a certain time.

Pursuant to 807 KAR 5:011 and the Commission’s Order, Inter-County provides this Notice to disclose the changes being proposed to the Renewable Energy Program tariff. The changes EKPC and Inter-County are proposing are as follows:

- To add clarifying language to Option B and Option C noting that option is only for commercial and industrial members. Commercial and industrial members have always been the only members that could take service under Option B and Option C so this is just been added to explicitly clarify this; and,
- To modify Rate, Option B such that the credit can only be the PJM International LLC (“PJM”) Locational Marginal Price (“LMP”). This change is being proposed to allow for consistency amongst all other tariff programs with credits. All other programs are based upon the LMP.

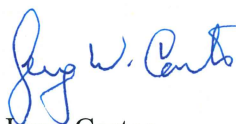

A copy of the red-lined proposed tariff changes along with a copy of the clean version of the proposed tariff changes are attached to this letter so that you can see each change being requested by Inter-County Energy and EKPC. Also, Inter-County Energy is attaching a red-line and clean version of the Renewable Energy Purchase Agreement that contains these same changes.

Since you are not currently taking service under this tariff, the proposed changes do not effect your current bill. corporation, association, or person may within thirty (30) days after the tariff is filed with the Public Service Commission, date of mailing this notice of the proposed rate change, submit a written request to intervene to the Public Service Commission, 211 Sower Boulevard, P.O. Box 615, Frankfort, Kentucky 40602, establishing the grounds for the request and including the status and interest of the party. If the Commission does not receive a written request for intervention within thirty (30) days of the filing of the tariff revision, the commission may take final action on the tariff filing. However, in the Commission's Order linked above, the Commission has set an intervention deadline of August 6, 2026. Written comments regarding this tariff filing may be submitted to the Public Service Commission through its web site at <http://psc.ky.gov/> or mailed to the Public Service Commission at 211 Sower Boulevard, P.O. Box 615, Frankfort, Kentucky 40602. Any person may examine this tariff filing at the offices of Inter-County Energy at the main office at 1009 Hustonville Road, Danville, KY 40422 or at the offices of the Commission located at 211 Sower Boulevard, Frankfort, Kentucky, Monday through Friday, 8:00 a.m. to 4:30 p.m. or through the Commission's Web site at <http://psc.ky.gov>.

Again, the Commission has suspended the tariff filing made by Inter-County Energy and has established Case No. 2026-00188. The procedural schedule contained in the Commission's Order established August 6, 2026 as the deadline for intervention in the proceeding.
