#### **FUEL ADJUSTMENT CLAUSE**

All rates are applicable to the fuel adjustment clause and may be increased or decreased by an amount per kWh equal to the fuel adjustment amount per kWh as billed by the wholesale power supplier plus an allowance for line losses. The allowance for line losses will not exceed 10% and is based on a 12-month moving average of such losses. The fuel clause is subject to all other applicable provisions as set out in 807 KAR 5:056.

#### **ENVIRONMENTAL COST RECOVERY SURCHARGE**

The Environmental Cost Recovery Surcharge will be applicable to all electric rate schedules offered by Inter-County Energy. The monthly billing amount under each of the schedules, to which this mechanism is applicable including the fuel clause, shall be increased or decreased by the amount of the environmental surcharge billed

by East Kentucky Power Cooperative to the distribution cooperative. The pass through mechanism used by East Kentucky Power Cooperative shall be the base/current approach.

#### **ENVIROWATTS**

Renewable Resource Power Service—100 kWh Block (Minimum size) or Greater \$0.275 per kWh or \$2.75 per 100 kWh Block. This rate is in addition to the regular retail rate of power and requires a one (1) year contract between the customer and the cooperative.

**Standard Rider**—This Renewable Resource Power Service is a rider to all currently applicable rate schedules. The purpose of this rider is to provide the consumer with a renewable source of energy that may be considered more environmentally friendly.



# IRRIGATION EQUIPMENT SAFETY

By following proper safety precautions, water and electricity can work together to properly hydrate your fields safely this summer.

- Locate electrical disconnects within sight of and within 50 feet of the equipment that turns off the electrical power to equipment.
- Label all switches on the control panel to ensure you can quickly turn off the power if necessary.
- Weatherproof, waterproof and rodent-proof your electrical enclosures/boxes to prevent damage to wires.
- Install electrical grounding hardware like a ground-fault circuit interrupter (GFCI) to prevent electrocution.
- Replace damaged electrical power cords.
- Install protective equipment, like a "jacketed" irrigation cable.
- Practice "lockout/tagout." Turn the power off and apply a padlock to the controls or switch to indicate someone is working on the system and it cannot be turned back on.

# Celebrating independence and cooperation

hough our Independence
Day celebrations may
look different this year
as our communities and our
nation stay safe amid coronavirus concerns, it's important
to note what has not changed:
the core principles and values
of Inter-County Energy and
the communities we serve.

Cooperatives around the world trace the roots of our Seven Cooperative Principles to the first modern cooperative founded in Rochdale, England, in 1844. These principles are a key reason that electric cooperatives such as Inter-County Energy operate differently from other electric utilities, putting the needs of our consumer-members first.

As we celebrate America's birthday, three of those seven co-op principles ring especially loud and clear:



Cooperatives are democratic organizations controlled by their members, who actively participate in setting policies and making decisions. The Inter-County Energy board members are elected from among our membership and are accountable to the membership. Our members have equal voting rights (one member, one vote).

## MEMBERS' ECONOMIC PARTICIPATION

Members contribute equitably to, and democratically control, the capital of our cooperative. At least part of that capital remains the common property of the cooperative. Members allocate surpluses for any or all of the following purposes: developing the cooperative; setting up reserves; benefiting members in proportion to

their transactions with the cooperative; and supporting other activities approved by the membership.



Inter-County Energy is autonomous and controlled by our members. If we enter into agreements with other organizations, including governments, or raise capital from external sources, the terms ensure democratic control as well as our unique identity.

Sixty-eight years before the first modern cooperative, America's founding fathers signed the Declaration of Independence, a moment that we commemorate on the July Fourth holiday.

"And for the support of this Declaration, with a firm reliance on the protection of Divine Providence, we mutually pledge to each other our Lives, our Fortunes, and our sacred Honor," reads the last sentence of that revolutionary document.

Now that's a real commitment to cooperation.
